## Minutes of Crestwood Village Five Executive Board Workshop April 15, 2025

## **OPEN SESSION:**

I. The Meeting was called to order at 10:00 AM with Pledge of Allegiance.

III. Minutes: Mary Ann Payne made a Motion to accept the minutes of the Executive Workshop of April 8, 2025, 2025, Betsy Gordon seconded the Motion. All approved.

IV. Officer Reports:

A. President report:

- 1. Meet the Mayor and Fire Safety presentation at 2:30 PM today.
- 2. Water rate increased in Manchester.
- B. Treasurer Report: Purchase of treasury bills in the amount of \$899,921.80 was confirmed by UBS.

## V. Administrator Report:

A. Awaiting an installation date from Automatic Doors Unlimited for the two rear doors in the Main Hall.

B. The Speed sign on Penwood showed an average MPH of 20.5 with 896 vehicles per day. 85% showed 24.5 MPH and one car was 41 MPH. Deerfield and Sunset will be observed in the future.

A. Mark Poyner expressed concern that the vacancy on the Board of Trustees, due to the resignation of Karen Pedersen, has not been filled by appointment as provided in the Bylaws and her position as Sergeant at Arms has not been filled.
